#### **Description:**

Our preferences are often imprecise or uncertain: you neither enjoy Caspar's talks more than Kevin's, nor vice versa; but nor are you clearly indifferent—if you discover that Kevin is giving \$1 to each audience member, you're still torn about which talk to attend. Likewise, our beliefs are often imprecise or uncertain: you're not more confident that Caspar owns green socks than that Kevin enjoys cabbage, nor vice versa; but nor are you clearly equally confident—if you discover that Kevin enjoys broccoli, you're still unsure which is more likely.

How *do* and *should* people make decisions in light of such imprecision (or uncertainty) in their preferences and beliefs? We'll tackle this question from a variety of theoretical and applied angles, asking questions such as: What's the best way to understand and model such cases? How is it rational to make decisions and form beliefs over time in such cases? And how does normative thinking about such cases inform our understanding of related empirical "biases"—such as (perhaps) <u>ambiguity aversion</u>, the <u>endowment effect</u>, the <u>attraction</u>, <u>repulsion</u>, and <u>compromise</u> effects, <u>rationalization</u>, and others.
